MESSAGE FROM THE PRESIDENT AND THE BOARD

The ritual of reflecting on the past year's accomplishments is very satisfying. It gives me a chance to appreciate the efforts of so many individuals who have made BCT's vision their own. The realization that BCT will be celebrating our 20th Anniversary next December gives me pause to reflect on how far we have come since those early days. It was a time when government austerity impacted its commitment to public trail building and maintenance. This opened the door for passionate volunteer groups such as ours to step up to ensure that trails remained properly managed on the landscape.

The complexity of managing year-round trails systems like the ones we manage in Kananaskis Country and Rocky View County (RVC) has not been lost on us, nor on our government partners. The last two years were spent on developing a new Master Trail Plan for West Bragg Creek that builds on the foundation of the previous plan. This massive effort by BCT, Alberta Forestry and Parks and various stakeholders has now given us a clear direction on where to strategically focus our efforts. We are also currently redefining our relationship with RVC which will hopefully develop into a fully collaborative partnership.

This last year continued the previous year's theme of governance transition with changes to our leadership team and

some key volunteer roles. We welcome Mike Duszynski to the Executive Director's chair, taking over from Michelle Dice in December. Frank Henvey stepped into the Operations Manager role in early January filling the hole left by Russell Wright's departure after last summer. Both Mike and Frank arrived just in time to oversee the start to the winter grooming season and were able to witness the resilience and dedication of BCT volunteers as we rebuilt the ski trail grooming program together. In the short time that Mike and Frank have been with us, they have continuously re-affirmed to us that we are in good hands. BCT wants to thank Michelle and Russ for helping lay the groundwork for their successors.

We also welcomed Kara Leinweber, who joined us in December in the role of Communications Coordinator. BCT values a clear and organized approach to both internal and external communications as the cornerstone to our organization's success. It helps build the community that in turn supports the work we do. Supporting initiatives such as the Trails 2025 fundraising campaign, creating snappy social media posts promoting our activities, and developing messaging around complex topics like logging impacts have been top of list for the communications team this year.



A BUSY YEAR FOR OPERATIONS

In summary, Bragg Creek Trails (BCT) has had a very challenging, yet positive year from an operations perspective.

We had been expecting the WBC Trails Master Plan to be approved by late August or early September 2023. So, our 2023 work plan was focused on doing preparatory trail work, to start implementing the short-term goals of the new trails plan in September-November. The delay by AFP to approve the trails plan until January 2024 meant that those trail projects had to be postponed until the 2024 season.







Although we had BCT board approval in March 2023 to purchase an all-electric tracked trail machine, design changes by the manufacturer of the MTT-154 and administrative changes at BCT meant that the purchase was not initiated during 2023/24. This lack of transportation capacity impacted our ability to access work projects on our more distant or difficult to reach trails, so those projects were postponed. This also had a major impact on our winter snow grooming program, resulting in significant additional hours of staff/volunteer work to do multiple passes to pack trails in a timely manner. Thank you to all the volunteers who put in many hours to get the work done.

WINTER SKI GROOMING

Ski grooming was particularly challenging, both from an equipment and a personnel perspective.

We entered the season with a significant amount of damaged and irreparable grooming equipment. Supply chain issues complicated our equipment repair and mobilization process.

Limited snowfalls early in the season and our limited capacity to do training with new volunteers due to out-of-commission equipment — all made for a ski season not quite on par with what our users have come to expect.

OPERATIONS MAINTENANCE REPORT

During mid October 2023 a Maintenance Manager, Dean Cockshutt, was hired. An inspection of the facility and equipment showed an absence of maintenance, which resulted in a full facility inspection and identification of deficiencies. The two most important deficiencies were a lack of Occupational Health and Safety documentation compliance and expired or missing fire extinguishers. Four safety related incident reports were filed.

Inspection of equipment showed the allseasons trail (AST) equipment to be in good condition with only basic annual maintenance required. All of the ski grooming equipment was found to be in poor condition with major damage and little maintenance. Both Kei trucks were non-operational due to engine damage caused by lack of maintenance. One truck was deemed to be non-economically repairable, and one truck may be serviceable after major engine repairs. Neither were available for the 2023/2024 grooming season. The Kubota tractor had been damaged in an electrical fire, had sheet metal and other damage, and required full annual service. Unsafe implements were decommissioned. The Yamaha snowmobile was damaged and will be sold. The Bearcat snowmobile required full annual service.

A Bobcat diesel UTV was leased to replace the out of service Kei trucks. Its ski grooming performance has been exemplary. A BRP Skandic work snowmobile was ordered to replace the divested Yamaha; this was picked up on Mar 19th and will be in operation in the coming days.



A certified heavy-duty mechanic was contracted to service the Snow Rabbit. Inspection showed many welding repairs on damaged components. Parts were ordered to replace damaged components and a full annual maintenance service was completed. Five new Rabbit operators took a two-day safety and operation certificate course.

Snow arrived early December and sufficient equipment was available to commence ski trail grooming. By December 31st over 400 hours of paid and volunteer maintenance time and \$28,000 had been expended to recondition the ski grooming equipment. A further \$5000 is expected in 2024 to repair the remaining Kei truck. BCT operating policies and procedures were reinforced and strictly adhered to. Preventative maintenance schedules were implemented.

TRANSCANADA TRAIL

The completion of the final 3.1 km of the TransCanada Trail in West Bragg Creek is more than just a physical connection; it's a bridge to enhanced community connectivity, increased recreational opportunities, improved fitness options and a steadfast commitment to safeguarding the natural beauty of the area. This achievement serves as a testament to the power of community collaboration, and the enduring value of outdoor spaces in our lives.

TRAILBLAZING TOGETHER: FUNDRAISING FOR TRAILS 2025

WBC TRAILS MASTER PLAN

BCT launched a major capital campaign in 2023 in support of our updated trails master plan. The <u>Trails 2025 Campaign</u> has a fundraising goal of \$1.66MM for 54.7 km of ski trail upgrading and 20 km of new all-season singletrack. This is a huge fundraising feat that we know we can achieve with help from our friends. BCT fundraising efforts include connecting with established Provincial and Federal Government infrastructure grants and sourcing parties that directly will benefit from our well-maintained and dynamic recreational destination. Regional municipalities, corporate partners, community members and local businesses are all beneficiaries of our trails network, directly or indirectly.

Additional capital initiatives in 2024 are underway for new equipment and for a new Trails Centre, a permanent structure to replace the existing hut at the west end of the parking lot.









FAT BIKING

XC Bragg Creek held the Frosty Fat Fest on January 20th, 2024 at West Bragg Creek. About 100 racers participated in this public fundraiser fat-bike event, in support of XCBC's Performance Mountain Bike team. Racers completed as many laps of the course as possible over three hours. The 6.6km loop included Ranger Summit, Snowy Owl and Mountain Road. It wouldn't have been possible without the efforts of BCT's groomers, Ed Reynolds and others, who worked tirelessly before and after the event to provide the best possible conditions.



SKI RACING

The 11th annual Alberta Youth Championships (AYC) took place at West Bragg Creek trails over the weekend of March 2 & 3, 2024. Skiers between the ages of 10 and 13 came from all over Alberta and as far away as the Northwest Territories and Saskatchewan. AYC is often the highlight of youth skiers' involvement in cross-country skiing. It provides an opportunity for them to meet new skiers from other clubs and compete for club pride in three different ski events while staying overnight at camp.

Grooming for an event like this requires extra effort and attention. A stadium needs to be laid out and the different formats also have different requirements. We had abundant snow over the weekend, which kept the amazing volunteer groomers from Bragg Creek Trails Association working hard, with long hours well into the night.

We are especially grateful to Oliver Brindle for taking the reins on grooming the courses, with additional help from Dan and Dean. We think Oliver has a special place in his heart for this event as he participated in it several years ago. Despite the cold temperatures, the organizers and volunteers were able to host the event, with some modifications to the format and distances. All ages skied a classic sprint event and costume relay on Saturday, and then a wave start skate event on Sunday. Our host club, XC Bragg Creek, won the aggregate small club banner with Foothills Nordic winning the aggregate large club banner. We are grateful for the extensive community support, from more than 50 volunteers to businesses donating amazing draw prizes, to folks offering 140 dozen yummy home-made baked goods.

VOLUNTEERS

THE LIFEBLOOD OF BCT

BCT is blessed with terrific volunteer support. We have 146 active volunteers, doing everything from trail building/maintenance to events organization to fundraising, communications and environmental work collaborating with Cows and Fish and the Elbow River Watershed. Not to mention our Board of Directors, who despite moving towards a governance function, still have their hands on many aspects of BCT operations.

Last year we hosted a few small community events, designed to attract new volunteers and to let existing volunteers meet and greet each other. Among these was the Brews for Bragg event held in May at Village Brewing. This was a partnership event between Village Brewing, Bike Shop and Bragg Creek Trails, with leadership provided by volunteer Vikki Mcguire.

We thank our volunteers wholeheartedly. Remember, we are always looking for more!

WELOVE OUR NATURAL

BCT's environmental stewardship committee works with local environmental groups to ensure best practices in trails management and operations. The committee had several initiatives on the go last year, one of them focused on air quality monitoring. Trail users now can use PAKU, the Purple Air application that provides data on air quality, so people know what they are breathing before they hit the trails.

The busy beavers living in the wetlands west of the main parking lot thrive alongside the trail users going back and forth nearby. A pond leveler was installed in August 2023 to help prevent future flooding on Mountain Road, a main artery trail, while allowing the resident beavers to thrive and continue with their good ecosystem engineering work. Other issues the committee will be focusing on include climate change adaptation, weed control, and nature-based education for all BCT users.





BCT is working with the Elbow River Watershed Partnership to improve the riparian health of Bragg Creek on either side of the South PRA bridge. This area is designated as critical habitat for bull trout, and the bank area on both sides of the creek has been heavily impacted by users, resulting in significant erosion, while the remaining soil was compacted, with large areas of bare/non-vegetated ground. These conditions can impact water quality and fish habitat. Thanks to the efforts of the volunteers who came out to plant, and the guidance from the ERWP and Leaf Ninjas, the health of this area will improve. Thanks to Flora Giesbrecht and the volunteers working on this initiative.

The EHS committee aims to educate trail users about any issues related to wildlife in the area. Educational pieces have been placed on the website about courage and bear safety and about deer rutting season and how to stay elk smart.

NOTES TO COMPILED FINANCIAL INFORMATION

Year Ended December 31, 2023

1. BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of Bragg Creek Trails Association as at December 31, 2023, and the statements of revenues and expenditures and changes in net assets for the year then ended is on the historical cost basis and reflects cash transactions with the addition of:

- accounts receivable
- inventory valued at cost
- property, plant and equipment amortized over their useful lives
- accounts payable and accrued liabilities

BACKGROUNDER

Bragg Creek Trails (BCT) Backgrounder: December 31, 2023

BCT's mission is to develop & maintain non motorized trails in the Bragg Creek (BC) area for public recreation.

- The Greater Bragg Creek Trails Association was incorporated as an Alberta not for profit society in 2004 & was approved as a a federally registered charity in 2007.
- In 2021, "The Greater Bragg Creek Trails Association" name was changed to "Bragg Creek Trails Association" & the trade name "Bragg Creek Trails" was adopted.
- BCT has raised & spent \$7.03 million on 178 km of Bragg Creek (BC) area trails.
- BCT has contributed 94,840 volunteer hours to Bragg Creek area trails (2011-2023).
- BCT has constructed & upgraded over 140 km of recreational trails in the West Bragg Creek (WBC) area of Kananaskis Country (KC) since 2010.
- BCT has raised & spent \$3.04 million on WBC trails in KC.
- BCT manages & maintains 166 km of trails in WBC KC in cooperation with Alberta Environment & Parks including handling most trail construction, maintenance & winter grooming operations.
- WBC Trails had an estimated 262,193 visitors in 2023 based on Alberta Parks Traffic/Trail Counts for the WBC & Fullerton parking lots.
- BCT has raised & spent \$3.99 million on BC trails in Rocky View County (RVC).
- BCT constructed & operates & maintains 12 km of trails in RVC & BC
 Provincial Park including the WBC TransCanada Trail (TCT) from the
 Hamlet of BC to WBC.
- BCT has created a positive economic impact on BC businesses with 262,193 visitors to WBC trails in 2023, which is a 483% increase since 2009 (45,000 visitors).
- Conservative estimate of the economic impact of the trails BCT has built in the Bragg Creek area = \$9 million per year based on 250,000 visitors per year. Source: The Economic Impact of Tourism in Kananaskis Country in 2011 (\$202.5 million, 1,103,000 visits). The Bragg Creek estimate is 20% of the calculated economic impact per person from this 2011 study.

All numbers provided above are since the inception of BCT unless otherwise noted.
